#### **NOTIFICATION**

<u>Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff</u> (LARSGESS) – SAFETY STAFF WORKING IN GRADE PAY Rs.1800/- Jan-2012, July-2012 and Jan-2013 cycles

1. In terms of Railway Board's letter No. E(P&A)I-2010/RT-2 Dated 29-03-2011 (RBE No.42/2011) circulated vide this office PS No.43/2011, the retirement / recruitment process under LARSGESS in respect of all Safety categories of staff in GP Rs. 1800/-, including Gangmen in GP Rs. 1800/-, is to be done twice in a year as per the time schedule laid down therein. However, the recruitment under the scheme could not be finalized as per the schedule laid down by the Board, resulting in backlog.

This Notification is issued in order to tide over the backlog and to maintain uniformity. Those employees, who have already applied under the scheme against Notifications issued by the respective Divisions for the cycles of January 2012, July 2012 and January 2013, need not apply again.

However, any employee, who has not applied earlier against Notification issued by Division, may apply against this Notification to the concerned Division subject to the condition that they fulfill the eligibility criteria on the cutoff date prescribed for any one of the cycles.

## 2. General Conditions:

Applications are invited from willing and eligible Safety category Staff working in GP Rs. 1800/-, seeking retirement and employment to a suitable ward under this scheme for the cycles of <u>Jan-2012</u>, <u>July-2012</u> and <u>Jan-2013</u>.

2.1 Safety Staff of following categories working in GP Rs. 1800/- are eligible to apply for Retirement and subsequent appointment to their wards:

## A) Operating Department

- 1) Pointsman
- 2) Shuntman
- 3) Leverman
- 4) Gateman
- 5) Traffic porters

### B) Civil Engineering Department

- 1) Gateman
- 2) Trolleyman
- 3) Keyman

# C) Signal & Telecommunication Department

1) Khalasi/ Khalasi Helper re-designated as Helper Grade II & Grade I attached to ESM/MSM/TCM/WTM.

# D) Mechanical & Electrical Department

- 1) Khalasi/ Khalasi Helper re-designated as Helper Grade II & Grade I assisting Loco Fitters/C&W Fitters, Fitters in Diesel Shed (Open Line & Workshops)/EMU/Elect. Sheds (Open Line & Workshops) and Train Lighting & AC Fitters (Open Line & Workshops), Crane Jamadar and Crane Khalasi.
- 2) Trolleyman of Departments other than Civil Engineering are also eligible under the Scheme as per Railway Board's letter No. E(P&A) I/2010/RT-2 dated 03-01-2012 (RBE No. 4/2012 circulated vide HQ office letter No. E(R&T) 890/60/1/SRRS (Policy) Vol. I dated 09-02-2012.

- 4. Employees working against substantive post carrying GP Rs.1800 are entitled to seek retirement under LARSGESS notwithstanding the fact that they have been granted Grade Pay higher than Rs.1800/- under MACPS.
- 5. All conditions for appointment, such as age-limits, educational qualifications etc. for the wards of such employees who seek retirement under this scheme shall be determined with reference to the cut-off date as indicated in Para 3(a) above.
- 6. Time Schedule for processing recruitment of wards and subsequent retirement of Safety Staff is as under:

- 6.1 The last date for submission of application for retirement and consideration of ward for appointment under the scheme is 21<sup>st</sup> June-2013.
- 7. The request for retirement under the scheme is purely voluntary and there is no element of compulsion on the part of the Administration.
- 7.1 The ward would be considered for appointment only in the lowest recruitment grade in the respective category from which the employee seeks retirement, depending upon his eligibility and suitability but not in any other category.
- 7.2 The employment under the scheme would be guaranteed only to those found eligible/suitable and finally selected as per procedure. The retirement of the employee and appointment of the ward will take place simultaneously.

### 8. <u>Mode of selection:</u>-

- i) Wards of eligible staff shall be subject to a written examination.
- ii) The Question Paper shall be set in English/Hindi/Marathi/Gujarathi.
- Question paper for the written examination shall be of 120 marks consisting of 60 multiple choice objective type questions, mainly aim to assess general knowledge/ awareness, mathematics, general science, reasoning etc. to be answered in 90 minutes duration.
- iv) Those qualifying in written examination will have to undergo medical examination in prescribed medical classification and only those wards who pass medical examination would be considered for empanelment and offered appointment.

## 9. How to apply:-

9.1 The staff belonging to the above safety categories working in GP Rs.1800/- fulfilling the eligibility criteria and seeking retirement and employment to a suitable ward under this scheme should submit the application in the format at **Annexure-I** to the notification to concerned Senior Divisional Personnel Officers/POs of the respective Workshops through their controlling Assistant Officers/Supervisors.

- 9.2 Attested copies of certificates in support of Age, Academic / Technical qualifications, caste etc. of the ward for whom employment is sought must be attached together with the application.
- 9.3 The photograph of the employee seeking retirement and the ward should be affixed in the space provided in the application and same should be attested by Controlling Asst. Scale Officer/Supervisor concerned.
- 9.4 The wards belonging to SC/ST community will submit caste certificate in the format given at **Annexure-II** and wards belonging to OBC community will submit caste certificate in the format given at **Annexure-III**.
- 9.5 In the case of OBC candidates the certificate specifically should indicate that wards does not belong to persons/sections (Creamy layer) mentioned in Col. 3 of schedule of the Govt. Of India, Department of Personnel and Training OM No. 36012/22/9-Estt.(SCT) dated 08-09-1993 and subsequent revision through OM No. 36033/3/2004-Estt.(Res.) dated 09-03-2004.
- 10. Sr.DPO/DPO/PO of Workshop should ensure that wide publicity is given to the notification at all levels so that willing employees belonging to the above categories submit their applications for consideration under the scheme.
- 11. Sr. DPO/DPO/PO of Workshop concerned should ensure that the applications received are scrutinized/verified and duly certified by them with reference to the eligibility norms prescribed both for serving employees belonging to the aforesaid category and their wards for whom employment is sought under the scheme. The Workshop PO should ensure the receipt of the applications from the eligible employees and cause to send the same to respective Division in whose territorial jurisdiction the workshop lies within the stipulated time. The respective Divisions to send the list of eligible candidates in hard as well as soft copy/pen-drive to this office in the format enclosed as **Annexure-IV**.
- 12. The qualifying service and age of the employees shall be verified and certified by the Division in consultation with associate finance as the employee will retire voluntarily simultaneously with the engagement of the ward.
- 13. It should be ensured that the time schedule prescribed under Para (6) above is strictly adhered to.
